

- There is no limit to the number of tickets any individual may purchase, except that a maximum of 1250 tickets will be sold: numbered 0001-1250.
- Odds of winning are approximately 1:1250 with 1 chance per ticket and only one prize awarded.
- One ticket per each \$10.00 and Six tickets per each \$50 donation.
- The prize is a new, factory made firearm.
- By obtaining a raffle ticket you attest that you are a law abiding citizen of USA, may legally possess the firearm won and agree to use the firearm only in a legal and safe manner.
- Last day to purchase tickets is February 23rd, 2013 at 3:00 PM EST. Drawing will take place on February 23rd, 2013 at Skyway Trap & Skeet Club St. Petersburg, FL at 3:30 PM EST.
- USCTF reserves the right to extend the ticket purchase/drawing period.
- Winner drawn will be provided with a Certificate for USCTF purchase price of the firearm won.
- Winning ticket numbers will be posted on the website www.myuscta.org. To protect the winner's identity, the winning names will not be posted.
- You may request winner information by submitting your Full Name, Address, City, State and Zip Code, Phone Number (including area code) and email address and include a self-addressed, stamped envelope.
- Proceeds of the "USCTF Youth Shotgun Program Fundraiser" raffle benefit the United States Clay Target Foundation to promote youth shotgun sports.
- You must be at least 18 years old and a legal resident of the United States to purchase a ticket.
- Winners must be at least 18 years old to take possession of a rifle or shotgun, and at least 21 years old to take possession of a handgun. Prizes are not transferable.
- The person designated on the ticket must claim the prize. ***Note: Tickets should not be made out to children below the age of 18, as they will not be allowed to take possession of any firearms.***
- Winners will be notified, using the name, address and phone number that the purchaser has written or requested to be on ticket stub.
- In the event that USCTF is unable to contact the winner it is the sole responsibility for the winning ticket holder to contact USCTF to claim their prize.
- Prizes are not transferable; the person designated on the ticket must claim the prize.
- Firearms can only be claimed at Cracker Boys Outdoors, Pinellas Park, FL.
- Firearms MUST be claimed within 30 days of the date of the raffle drawing or the winner will forfeit the firearm prize to the USCTF.
- Winner is responsible for any fees associated with Federal and State background check requirements.
- Raffle is void where prohibited.
- All Federal Bureau of Alcohol Tobacco and Firearms (BATF) rules apply and by claiming a firearm prize you agree to provide all information necessary for the transfer of the firearm won.
- All firearm transfers will be done through a Federal Firearms Licensed (FFL) dealer – Cracker Boys Outdoors, Pinellas Park, FL - and all applicable Federal and State laws will apply, including the state laws for the legal residence of winning ticket holder.
- Winners may be required to verify that ownership of the firearm won is legal in their state, city or town, prior to taking possession of prize.
- At no time will USCTF take possession of any firearm involved in this raffle; winners will receive firearms directly from a FFL dealer only, all applicable laws will apply.
- No purchase is necessary to enter this raffle. One entry per person per household may be entered by requesting a ticket from the USCTA by printing their Full Name, Address, phone number and email address and include a self-addressed stamped envelope, postmarked no later than February 13th, 2013.
- USCTF limits any and all liability to the purchase price of ticket purchased.
- USCTF will not sell or provide your contact information to any 3rd party organization.
